**Entries:** Entries will not be accepted without fees. Faxed, telegraph, telephone, and unsigned entries cannot be accepted. Entries not on an Official AKC entry form, and photocopies of entry forms without the Agreement and Rules on the reverse side of the Official AKC entry form are not acceptable. No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. No refund for duplicate entries, errors on entry blanks. **Closing Date:** Entries for this VST test close Monday, April 21, 2014 at 5 PM, CDT, after which time entries cannot be accepted, cancelled, altered, or substituted. Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.

**Drawing of entries** for VST Test: A drawing will be held at 8 PM, Monday, April 21, 2014 at Burger King, 2045 S. 17<sup>th</sup> St., Lincoln, NE to fill entry limits. The drawing shall be completely random among all entries received, and in accordance with provisions set forth in the Tracking Regulations Ch. 1, Sec 17. Upon notification, alternates shall have the option of accepting or refusing the opportunity to participate in the test. **Bitches in season may participate.** The Test Secretary and judges are to be notified prior to the drawing for running order that a bitch is in season. The last track(s) to be laid shall be reserved for the bitch(es) in season. If there is more than one bitch in season, a second draw for these bitches will be held.

**INSTRUCTIONS**

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories or dogs may be entered and shown in Best of Breed competition; Dogs that are Champions of Record and dogs which according to their owners records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in the show's premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to A.K.C. (For complete rule refer to Chapter 11, Section 3).
