**Show Site:**

- The facility is enclosed but not climate controlled. Come prepared in the event that the weather is cool.
- This trial will be held indoors; rolled packed dirt arena; two 100' x 100' rings.
- There is plenty of grassy space to exercise dogs at this site.
- PLEASE CLEAN UP AFTER YOUR DOG. Exhibitors are responsible** for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.
- Crates:** Crates may be left overnight; however, the Go Dogs! Agility Club and the Chance Ridge Event Center will not be responsible for any lost or damaged items left at the show site.

**Parking:**

- There is plenty of close parking at this facility.

**RV Parking:**

- Day-to-Day: GDAC will accept day-to-day move-ups. The request for moving up must be made in writing at the trial site to the Trial Secretary no later than 30 minutes after the end of the trial each day.

## NOTICE TO EXHIBITORS

### **SAFETY, BEHAVIOR and LIABILITY**

- **The safety of the dog** is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the event committee, be asked to leave the show site. In such case, no refund of any fees paid will be made.
- The Go Dogs! Agility Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.
- The Go Dogs! Agility Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Go Dogs! Agility Club or any official thereof.
- **All dogs must be on leash** at all times when on trial grounds except when in the designated warm-up area or competing on the course.
- **The Go Dogs! Agility Club may cancel this event in extreme weather conditions.**

### **REFUNDS**

- **No entry fee** will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- **No entry fee** will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Event Committee.
- **Bitches in season** are not permitted to compete in Agility Trials. As such, GDAC will refund the entry fee paid minus \$5.00 per run for bitches unable to compete for this reason upon presentation of a veterinarian certificate. This certificate must be presented to the Trial Secretary prior to the start of judging on the first day of the trial or cluster of trials.

### **RINGSIDE**

- **Dogs may arrive** any time prior to judging if the dog has a valid temporary or permanent jump height card. Otherwise, they must be available for measuring prior to the start of their class if a VMO or AKC Field Rep is available to measure dogs. All dogs not needed for further judging will be excused.
- **Judges are not required** to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.
